Our Equine Encounters program consist of: Equine Assisted Learning which focuses on developing life skills such as effective communication, Equine Assisted Psychotherapy which includes a licensed Mental Health Provider for deeper therapeutic experience, and Horse Essentials which focuses on general horsemanship. We also provide periodic workshops for Youth in the Juvenile Justice System and Cancer Patients and their families. In 2023, we provided services for 81 participants in 600 classes and 65 attendees in 20 Workshops.
